SUBJECT: 10/1/2018 Basic Calculation for Equalization Assistance Report (CHAR 55-1) and Equalization Assistance Detail Report (CHAR 64-1)

The October 1, 2018 charter apportionment is complete. The CHAR55-1 and the CHAR64-1 equalization assistance reports for charters are posted on each charter school's home page of the Arizona Department of Education (ADE) School Finance website at <http://www.azed.gov/districts>. All eligible charters were paid based on their estimated counts submitted September 14, 2018 by 4:30 p.m. There are 69 Charters being paid on FY2019 AzEDS results as of September 12, 2018. **It is our expectation that FY2019 AzEDS results will be used in the calculation of your Base Support Level for all LEAs, beginning with the November 1, 2018 payment.** The Charter School Student Enrollment Summary report is available for download and review from the School Finance website. Important Notes:

- **CAA Reduction:** Preliminary Charter Additional Assistance reduction, \$13,628,800, per House Bill 2663, was included by August 1st payment. (CHAR64-1 report)
- **SSW Adjustment:** Preliminary Small School Weight adjustment was included in the August 1st payment. (CHAR64-1 report)
- **K-3 Reading:** Per A.R.S 15-211, Each school district and charter school shall annually submit to the department of education on or before October 1 an updated K-3 reading program plan that includes data on program expenditures and results, except that beginning in fiscal year 2016-2017, a school district or charter school that is assigned a letter grade of A or B pursuant to section 15-241 shall submit this plan only in odd-numbered years. Submitted plans appeared on the agenda for the State Board of Education meeting held on 8/27/18. Those who were approved have had the funding

- **FY2018 Statewide Recalculation:** The Fiscal Year 2018 Statewide Equalization Recalculation has been completed. The positive adjustments were included in the September 1st payment as lump sum adjustments through the CHAR 64-1 report and negative adjustments have been included in the October 1st payment and will be taken over the entire fiscal year, 3/12ths taken in October and 1/12th each payment thereafter. - **Audit Expense Adjustment:** All adjustments have been included on your September 1, 2018 apportionment based on your submitted adopted budget as of July 30, 2018. The chart below outlines the locations in which reporting by the Charter may have been required:
